In New Asian Disorder: Rivalries Embroiling the Pacific Century, Lowell Dittmer and his team explore the recent political disorder in East Asia resulting from growing Sino-American polarization. The rise of China in recent years is widely regarded as a momentous shift in the global balance of power. China is now extending sovereignty into the East China Sea and the South China Sea, constructing a new set of global financial institutions and replacing "universal values" with technologically enhanced nationalism. The country's "Belt and Road Initiative" is also tainted by the vast ambition to realize the "China Dream" within the foreseeable future. In response to China's challenge, the United States has abandoned its "constructive engagement" policy towards the rising power and engaged in a trade war. Sino-American relations have been at a historical trough since the normalization of their relationship in the late 1970s. This book sheds new light on the current political disorder in the East Asian international arena. The new Asian disorder is analyzed from three perspectives: the first focuses on identity, the second on political economy, and the third on the triangular dynamic. This collection of essays concludes that, unless and until consensus can be reached on a coherent new framework for cooperation and rule enforcement among different stakeholders in East Asia, the current disorder may be expected to persist.

**Lowell Dittmer** is a professor in the graduate school of the Charles and Louise Travers Department of Political Science at University of California, Berkeley. He has published widely on contemporary China and Sino-foreign relations. He is most recently the author of *China's Asia: Triangular Dynamics since the Cold War* (2018) and the editor of *Taiwan and China: Fitful Embrace* (2017). "Focusing on the impact of Xi Jinping and Donald Trump, this book sees rivalries undermining the post-Cold War order but not leading to a full breakdown. Stress is on identities, strategies, and triangles related to the Sino-US rivalry. Dittmer argues that these factors will drive further changes. Readers will find a diversity of approaches on a most critical bilateral relationship."

Self-Feminizing and the Claiming of Postcolonial Chineseness (愛神的國際關係:從女性化角色釋放後殖民中國性)

Eros of International Relations: Self-Feminizing and the Claiming of Postcolonial Chineseness is a distinctive work that explores the much-neglected Chinese perspective in broader international relations theory. Using the concept of "self-feminizing"—adoption of a feminine identity to oblige and achieve mutual caring as a relational strategy this book argues that postcolonial actors have employed gendered identities in order to survive the squeezing pressure of globalization and nationalism in their own ways. Sovereign actors who have historically claimed to act on behalf of Chineseness have taken advantage of the images of femininity thrust upon them by transnational capitalism, the media, or intellectual thought.

Shih illustrates the feminist potential for emancipation through a range of empirical examples, showing that women of various Chinese characteristics, acting on behalf of their nation, city, and corporations, reject the masculinization of their groups of belonging as remedy for inferiority or threat. Carried out effectively, Shih argues, actors who self-feminize have the potential to deconstruct the binaries of masculine competition and seek alternative strategies under the postcolonial global order.

*Eros of International Relations* is a welcome contribution that ties together revisionist yet friendly reflections on the current studies of postcolonialism, international relations, relational theory, China studies, cultural studies, and feminism.

**Chih-yu Shih** is national chair professor and university chair professor at National Taiwan University. He has written extensively on and taught Chinese studies, anthropology of knowledge, and international relations theory. "Chih-yu Shih is one of the pioneers doing gender and international relations in China. His critical renovation of postcolonial feminism demonstrates that selfromanticization, non-solution, and inconsistency are plausible strategies that help us transcend the boundaries internalized by hegemonic discourse."

Traversing from the rapidly urbanising county-level city of Fuging to the remote mountainous kingdom of Lesotho in Southern Africa, Searching for Sweetness is one of the first and most extensive ethnographies linking rural-to-urban migration in China with Chinese migration to Africa. Against the backdrop of China's national struggle for modernity and globalisation, Sarah Hanisch examines Chinese migrant women's complex and ever-shifting struggles for upward social mobility across different generations and localities in China and Lesotho. Embedding the women's individual portraits into larger historical contexts, Hanisch illustrates how these women interpret and narrate their migratory and everyday experiences through and beyond powerful state metanarratives on 'sweetness' and 'bitterness'. In her exploration of migratory identities and projects that have been overlooked by previous studies, Hanisch brings uniquely gendered, multi-sited, and intergenerational perspectives to existing scholarship on Chinese internal and international migration.

**Sarah Hanisch** holds a PhD in Chinese studies and an MA in global studies. She has conducted field research in China, Lesotho, South Africa, and Tanzania.

This book sheds new light on the history of charity among Chinese overseas and its place in the history of charity in China and in the wider history of global philanthropy. It finds that diaspora charity, besides serving traditional functions of helping the sick and destitute and supporting development in China, helped to build trust among dispersed hometown networks while challenging color boundaries in host societies by contributing to wider social causes.

## More than 1001 Days and Nights of Hong Kong Internment

More Than 1001 Days and Nights of Hong Kong Internment is the wartime journal of Sir Chaloner Grenville Alabaster, former attorney-general of Hong Kong and one of the three highest-ranking British officials during the Japanese occupation. He was imprisoned by the Japanese at the Stanley Internment Camp from 1941 to 1945. During his internment, he managed to keep a diary of his life in the camp in small notebooks and hid them until his release in 1945. He then wrote his wartime journal on the basis of these notes. The journal records his day-to-day experiences of the fall of Hong Kong, his time at Stanley, and his eventual release. Some of the most fascinating extracts cover the three months immediately after the fall of Hong Kong and when Alabaster and his colleagues were imprisoned in Prince's Building in Central and before they were sent to the camp, a period little covered in previous publications. Hence, the book is an important primary source for understanding the daily operation of the Stanley Internment Camp and the camp's environment. Readers will also learn more about the daily life of those imprisoned in the camp, and Alabaster's interaction with other prisoners there.

**David St Maur Sheil** is the great-grandson of Sir Chaloner Grenville Alabaster and has been conducting research into his family's long history in Hong Kong and China. "A prominent figure in pre-war Hong Kong, Alabaster was one of the leaders of the British community in Stanley Internment Camp. His recently discovered journal provides a detailed and candid account of the routines, anxieties, and hardships of camp life. It also offers new insights into the complex politics and divisions among internees. Public Figure, Private Man (何東爵士傳記)

Sir Robert Ho Tung (1862-1954) is a compelling figure in Hong Kong history. He is regularly portrayed as the colony's greatest philanthropist and wealthiest man of his day, the first Chinese to live on the Peak, and, at the end of his life, the 'Grand Old Man of Hongkong'. The illegitimate son of a Chinese mother and European father, he was highly sensitive about his mixed heritage though he consistently made the most of his fate. He was a man perfectly in tune with his place and time, his success driven as much by his entrepreneurial talents as by his being Eurasian. This book shows him in all his immense variety-clerk with the Imperial Maritime Customs, chief compradore of Jardine Matheson, financial wizard, husband and lover, patriarch of a large family of five sons and eight daughters, loyal British subject but also, paradoxically, Chinese patriot. China's president Yuan Shikai awarded him the Order of the Excellent Crop, and King George V knighted him.

May Holdsworth's thoughtful and deftly written account of the life is the first full-length biography in English. Given unique and unprecedented access to family and personal papers, including letters, diaries, notes, and photographs, she offers a nuanced perspective on a public but also private man. Her book will be a rich resource for historians and general readers interested in the men and women who played a key part in the shaping of nineteenth- and early twentieth-century Hong Kong.

May Holdsworth is a writer based in Hong Kong. Her previous books include Foreign Devils: Expatriates in Hong Kong, and The Palace of Established Happiness: Restoring a Garden in the Forbidden City. She is co-editor, with Christopher Munn, of the Dictionary of Hong Kong Biography (HKUP, 2012), and co-author with him of Crime, Justice and Punishment in Colonial Hong Kong: Central Police Station, Central Magistracy and Victoria Gaol (HKUP, 2020).

In Hong Kong's Last English Bishop, Philip L. Wickeri explores the life and times of John Gilbert Hindley Baker, who served as Bishop of the Anglican Diocese of Hong Kong and Macao from 1966 to 1981. Baker lived through exciting times, as a missionary in wartime and revolutionary China, as a priest in America during the early years of the Cold War, and as a mission leader in the Church of England when churches in many parts of the world were becoming independent, before returning to Hong Kong where he was elected bishop. He was a faithful correspondent and a prolific writer throughout his life, offering a personal commentary on the churches and the societies in which he lived. Wickeri has made extensive use of Baker's writings and other archival materials to provide a vivid picture of his life and work. Bishop Baker was instrumental in working for reconciliation after the 1967 riots, expanding the work of the diocese, and engaging Hong Kong with the wider world. In 1971, he opened a new era in the Anglican Communion by legally ordaining the first women priests. This book is indispensable for understanding the development of the Hong Kong Sheng Kung Hui (Anglican Church) at a time when the growth of Hong Kong as a vibrant modern city was at its peak.

**Philip L. Wickeri** is advisor to the archbishop on theological and historical studies, Hong Kong Sheng Kung Hui. He is the editor of the HKU Press book series "Sheng Kung Hui: Historical Studies of Anglican Christianity in China," and is a widely recognized authority on the history of Christianity in China. The crisis of masculinity surfaced and converged with the crisis of the nation in the late Qing, after the doors of China were forced open by Opium Wars. The power of physical aggression increasingly overshadowed literary attainments and became a new imperative of male honor in the late Qing and early Republican China. Afflicted with anxiety and indignation about their increasingly effeminate image as perceived by Western colonial powers, Chinese intellectuals strategically distanced themselves from the old literati and reassessed their positions vis-à-vis violence. Jun Lei is an assistant professor of Chinese in the Department of International Studies at Texas A&M University. Her research focuses on the history of sexuality and gender issues represented in twentieth-century Chinese literature, film, and visual media. She co-authored *First Step: An Elementary Reader for Modern Chinese* (2014) and *First Step: Workbook for Modern Chinese* (2014).

The Many Faces of Ruan Dacheng: Poet, Playwright, Politician in Seventeenth-Century China is the first monograph in English on a controversial Ming dynasty literary figure. It examines and re-assesses the life and work of Ruan Dacheng (1587-1646), a poet, dramatist, and politician in the late Ming period. Ruan Dacheng was in his own time a highly regarded poet, but is best known as a dramatist, and his poetry is now largely unknown. He is most notorious as a 'treacherous official' of the Ming-Qing transition, and as a result his literary work-his plays as well as his poetry-has been neglected and undervalued. Hardie argues that Ruan's literary work is of much greater significance in the history of Chinese literature than has generally been recognised since his own time. Ruan, rather than being a transgressive figure, is actually a very typical late Ming literatus, and as such his attitudes towards identity and authenticity can add to our understanding of these issues in late Ming intellectual history. These insights will impact on the cultural and intellectual history of late imperial China.

This edited volume advances research on world literature by bringing in new developments in Chinese/Sinophone literatures and adds a much-needed new global perspective on Chinese literary studies beyond the traditional national literature paradigm and its recent critique by Sinophone studies. The purpose of this book is to explain both the historical context and current practices of land administration in Hong Kong. Although Hong Kong has an open and business-friendly environment, it is underpinned by a socialist leasehold land tenure system. The government is landlord to virtually all land and so it plays a pivotal role in the administration of this scare, and therefore, valuable resource.

As land administration is governed by private contract law rather than legislation, it is constantly evolving with the courts handing down significant decisions on a regular basis. Government practice has to respond to this, as well as the community's concern on how best land can be administered. The fifth edition has some substantial and important updates which should continue to be useful to both students and practitioners of surveying, architecture, planning and law, as well as the wider business and financial community.

**Roger Nissim**, FRICS FHKIS RPS, became chartered in 1968 and practised as a surveyor in England before coming to Hong Kong in 1973. Dazzled by the twilight of 17th-century painter Aert van der Neer's *Moonlit Landscape with a Road beside a Canal* (1645– 1650), contemporary Spanish artist Alberto Reguera created twenty-three paintings as an homage to the celebrated artist of the Dutch Golden Age. Each of Reguera's paintings display an in-depth study of the representation of light and sky in the European tradition of painting, while engaging in a dialogue with Van der Neer's Moonlit Landscape. The sensitive depiction of light in the night sky most inspired Alberto Reguera, in part because of the similarities to his own work. This new series of paintings examines and connects directly to Van der Neer's masterpiece, and the important painterly achievements of the Dutch painter's generation.

The exhibition and accompanying publication is the second collaboration between the University Museum and Art Gallery (UMAG) and Alberto Reguera. While the first exhibition *Blue Expansive Landscape* (2015) was notable for the display of the painter's two- and three-dimensional works, and his innovative ways of painting beyond the canvas, *Homage to Aert van der Neer* is a similarly complex endeavour that has been achieved through a successful partnership with UMAG, the Museo Nacional Thyssen-Bornemisza and the artist.

Alberto Reguera (Segovia, 1961) is a Spanish artist currently based in Madrid for whom travelling—across Spain and abroad—has become a way of life. 在《眾裏尋她:公義在香港》,陳文敏教授通過其個人經驗和重要 案例,探討香港法律制度的核心價值。本書解釋和釐清了一些有關 香港法律的常見問題。例如大律師如何為有罪的人作辯護?法律偏 袒於有財有勢的人嗎?我們是否在任何情況下皆要遵守法律?在人 權與國家安全互相抵觸的情況下,兩者該如何取得平衡?公平又如 何與行政效能協調?我們可以因自由被濫用而否定它嗎?陳教授在 書中亦會談及法律專業和專業精神,並指出法律專業備受尊崇在於 律師嚴格堅持其專業操守,並致力於維護公義與公平。本書所談及 的案例涵蓋不同的法律範疇,並橫跨陳教授數十年的執業經歷。通 過這些真實案例,陳教授不但令讀者更明白香港的法律制度如何運 作,亦讓讀者更深入地考量法律體制、法律專業、正義在現代社會 的角色和法治的重要性。 In an engaging, revisionist study, Carroll argues that in the century after the Opium War, Hong Kong's colonial nature helped create a local Chinese business elite. By the end of the nineteenth century, the colonial government saw Chinese businessmen as allies in establishing Hong Kong as a commercial center. The idea of a commercially vibrant China united them. Chinese and British leaders cooperated on issues of mutual concern, such as the expansion of capitalism and political and economic directions for an ailing China. These Chinese also found opportunities in the colonial system to develop business and commerce. In doing so, they used Hong Kong's strategic position to underscore their own identity as a distinctive group unlike their mainland counterparts. Nationalism took on a specifically Hong Kong character.

Chan illuminates fundamental themes and basic values in Hong Kong's legal system by using his own experience and drawing on interesting and important cases. The book explains and demystifies some of the most frequently asked questions about the law: How does a lawyer defend someone who is guilty? Does the law favour the rich and the resourceful? Is there a duty to obey the law in all circumstances? How can human rights and national security coexist in balance if their goals conflict in certain situations? How can fairness be reconciled with administrative efficacy? Is an abuse of freedom a justification for denying it? He also casts light on legal profession and professionalism, arguing that the legal profession is honourable only because lawyers live up to a high ethical standard and are committed to the values of justice and fairness.
