Notes on Contributors

Stephen Wing-Kai Chiu is Professor in the Department of Sociology, The Chinese University of Hong Kong. His research interests are in the sociology of development, industrial relations, social movement, and East Asian studies. He has authored and coauthored several books, including *The City-State in the Global Economy: Industrial Restructuring in Hong Kong and Singapore* and *East Asia and the World Economy* (with Alvin Y. So). His articles have appeared in *Organization Studies* and *China Information*.

Lisa Fischler is Assistant Professor in the Department of Political Science at Moravian College in Pennsylvania. Her research interests include the politics of democratization in East Asia, women in Chinese societies, gender and political transitions, and women's movements in comparative perspective. Her dissertation concerns gender and politics in Hong Kong. She is currently working on projects concerning political women in contemporary Hong Kong and the history of Hong Kong women's activism in China.

Ching-Kwan Lee is Associate Professor in the Department of Sociology at the University of Michigan. Her research interests are work, gender, China, postsocialist transition, and ethnography. She is the author of *Gender and the South China Miracle: Two Worlds of Factory Women* (University of California Press, 1998) and *In the Twilight of Socialism: Trajectories of Chinese Labor Politics* (University of California Press, forthcoming). She has also published articles in *Theory and Society*, *American Sociological Review*, *Modern China*, *Gender and Society*, and *Labor Studies Journal*.

Eliza W.Y. Lee is Associate Professor in the Department of Government and Public Administration, The Chinese University of Hong Kong. Her research interests include the politics of social policy development in Asian late-industrializers, nongovernmental organizations, and gender politics. She has published articles in *Public Administration Review*, *International Review of Administrative Sciences*, and *Asian Survey*, as well as a book chapter on gender and the administrative class in Hong Kong.

Carole J. Petersen is Associate Professor in the Faculty of Law, University of Hong Kong, and also Director of the Centre for Comparative and Public Law, a research centre within the Faculty of Law. Petersen has published numerous articles and book chapters on women and the law in Hong Kong. She has also published in the areas of disability discrimination, sexuality discrimination, and the preservation of academic freedom in Hong Kong. Her current research focuses on the enforcement of antidiscrimination law, including the use of alternative dispute resolution for complaints of discrimination and sexual harassment. Petersen is currently serving as a member of the Hong Kong Equal Opportunities Commission's Task Force on Equal Pay for Work of Equal Value, which is overseeing a study of salary policies in Hong Kong's public sector.

Siumi Maria Tam is Associate Professor in the Department of Anthropology and concurrently chairs the Gender Studies Program at The Chinese University of Hong Kong. A social and cultural anthropologist, she is interested in cultural identity issues in relation to gender, migration, and work, with an area focus on Hong Kong, China, and the Chinese overseas.

Wai-Ching Wong is Associate Professor in the Department of Modern Languages and Intercultural Studies, The Chinese University of Hong Kong. Her research interests include Christianity, postcolonialism, and feminism in Hong Kong and Asia. She is the author of *"The Poor Woman": A Critical Analysis of Asian Theology and the Chinese Contemporary Stories by Women* (2002) and has published articles in *Asia Journal of Theology*, *In God's Image*, and *Jian Dao: A Journal of Bible and Theology*. She is currently involved in a project on Asian Christianity jointly sponsored by Council of the World Mission and the Centre for Advanced Study of Religion and Theology at the Cambridge University.
